EMERGENCY OVERVIEW

WARNING

Section 4: FIRST AID MEASURES

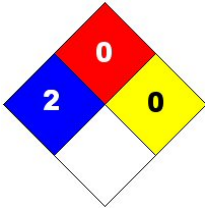
